A BILL FOR AN ACT

To further amend Title 14 of the Kosrae State Code, by amending Section 14.104 thereof, to amend the port and dock fees: and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to amend Title 14 at Section
2 14.104 to amend the port and dock fees of the State.

3 Section 2. Amendment. Section 14.104 to Title 14 of the Kosrae State Code as
4 amended by S.L. Nos. 5-157, 5-175, 7-1 and 10-111, is hereby further amended to read
5 as follows:

6 “Section 14.104. Port and Dock Fees. The Kosrae Port Authority or its
7 designee shall collect the following fees from masters and agents of vessels
8 using the ports and docks in the State of Kosrae:

9 (1) Entry Fee

10 (a) \$0.20 per gross registered ton for vessels of specified tonnage;

11 (b) \$50.00 is charged as entry fee on all boats authorized entry to any
12 designated port within the territorial waters of Kosrae State and further
13 classified as yachts, sail boats, and pleasure boats.

14 (2) Anchorage and Mooring Fees

15 (a) \$0.10 per gross registered ton per 24 hours or fraction thereof for vessels
16 of specified tonnage;

17 (b) \$40 for yacht, sail boat, pleasure craft and related vessel docked for a

1 period or 120 days or less and with additional \$1 charge per day for
2 extensions of anchor schedule beyond 120 days.

3 (3) Dockage Fee

4 (a) \$0.14 per gross registered ton per 24 hours or fraction thereof for vessels
5 of specified tonnage;

6 (b) Vessels and boats defined as yachts, sail boats and pleasure boats and
7 pleasure crafts shall be charged \$30 as dockage fee for maximum stay of
8 30 days at any officially designated port of entries in Kosrae State and
9 within additional charge of \$1 per day for stay over 30 days and more;

10 (4) Wharfage Fee

11 (a) \$1.25 per revenue ton for cargo conveyed over the dock.

12 (b) \$0.50 per metric ton of fuel conveyed from tanker to storage fee tank.

13 (5) Transshipment Fee. A transshipment fee of \$1.25 per revenue ton of fish
14 or other cargoes off-loaded or transferred onto a carrier vessel at the port or in
15 the territorial waters of Kosrae State.

16 (6) Handling Charges

17 (a) \$100 line handling fee per vessel.

18 (b) \$50 line boat per service.

19 (7) Navigational Aids Dues of \$15 per trip.

20 (8) Passenger fee. There shall be a charge of \$3.00 for every person that boards
21 a vessel through any port within the control of Kosrae Port Authority.

22 Section 3. Effective Date. This act takes effect upon the approval of the
23 Governor or upon its becoming law without such approval.
