A BILL FOR AN ACT

To appropriate the sum of \$1,000.00 from the Local Revenue Fund of the Kosrae State Treasury to contribute to the 2016 June 06th Memorial Holiday and related celebrations and festivities of the Malem community; and for other purposes.

1 Section 1. Appropriation. The sum of \$1,000.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the purpose of contributing to the 2016
3 June 6th Memorial Holiday and related celebrations and festivities of Malem community.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered, and accounted for in accordance with applicable laws. The allottee of the
6 funds appropriated shall be the Governor of the State of Kosrae, who shall be
7 responsible for ensuring that these funds, or so much thereof as may be necessary, are
8 used for the purpose for which are appropriated and that no obligations are incurred
9 in excess of the sum appropriated.

10 Section 3. Effective Date. This act shall become law upon approval by the
11 Governor or upon its becoming law without such approval.
