### A BILL FOR AN ACT

To appropriate the sum of \$3,500.00 from the Local Revenue Fund of the Kosrae State Treasury to contribute to the lodging for the players and coaches representing the State of Kosrae to the 2016 Micronesian Baseball Classic to be held in Saipan on June 24<sup>th</sup> to July 1<sup>st</sup>, 2016; and for other purposes.

1 Section 1. Appropriation. The sum of \$3,500.00 is hereby appropriated from 2 the Revenue Fund of the Kosrae State Treasury to contribute to the lodging for the 3 players and coaches representing the State of Kosrae to the 2016 Micronesian Baseball Classic to be held in Saipan on June 24<sup>th</sup> to July 1<sup>st</sup>, 2016. 4 5 Section 2. All funds appropriated by this act shall be allotted, managed, 6 administered and accounted for in accordance with applicable laws. The allottee of the 7 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible 8 for ensuring that these funds, or so much thereof as may be necessary, are used for the 9 purpose for which are appropriated and that no obligations are incurred in excess of the 10 sum appropriated. The authority of the allottee to obligate funds appropriated by this act 11 shall lapse on September 30, 2016. 12 Section 3. Effective Date. This act shall become law upon approval by the 13 Governor or upon its becoming law without approval. 14 PASSED BY THE ELEVENTH KOSRAE STATE LEGISLATURE ON THE 30<sup>TH</sup> 15 16 OF MAY, 2016.
