A BILL FOR AN ACT

To appropriate the sum of \$1,000 from the Revenue Fund of the Kosrae State Treasury for the purpose of funding the July 20th celebration activities for the Utwe Municipality; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Purpose. To fund the July 20th celebration activities for the Utwe 1 2 Municipal. 3 Section 2. Appropriation. The sum of \$1,000 is hereby appropriated from the 4 Local Revenue Fund of the Kosrae State Treasury to fund the July 20, 2016 celebration 5 activities for the Utwe Municipality. 6 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed, 7 administered and accounted for in accordance with applicable laws. The allottee of the 8 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible 9 for ensuring that these funds or so much thereof as may be necessary, are used for the 10 purpose for which are appropriated and that no obligations are incurred in excess of the 11 sum appropriated and that no obligations are incurred in excess of the sum appropriated. 12 Section 4. Effective Date. This act shall become law upon approval by the 13 Governor or upon its becoming law without such approval. 14 15 PASSED BY THE ELEVENTH KOSRAE STATE LEGISLATURE ON THE 30TH 16 DAY OF MAY, 2016.
