A BILL FOR AN ACT

To further amend Section 2 of Kosrae State State Law No. 11-11, as amended by S.L. No. 11-29 and State Law No. 11-43, to eliminate certain projects therein and redirect funding to other projects; and for other purposes.

1 Section 1. Amendment. Section 2 of the Kosrae State Law No. 11-11, as amended
2 by S.L. No. 11-29 and S.L. No. 11-43, is hereby further amended to read as follows:

3 Section 2. Apportionment. The sum appropriated herein shall be apportioned as
