Dear Mr. Speaker:

I present my complements and warm regards to you and the Honorable Members of the Legislature.

Upon review of Legislature Bill No. 11-124 LD.5, I thank you for the hard work and vigilant deliberations on said bill but regretfully must bring back to your attention a few items therein not consistent with FSM Public Law No. 19-32. With the understanding that an amendment was to be made to the aforementioned FSM appropriation law to allow the insertion of non infrastructure projects, four (4) project items were submitted to you by IPIC based on multiple dialogues involving initiators of said appropriation law. Unfortunately, the appropriation bill became law before such amendment could be made. Therefore, Mr. Speaker, I must bring back to your attention Legislative Bill No. 11-124 LD.5 and have marked herein as Item Veto specific sections to be revisited to become consistent with the FSM PL 19-32 as is.

I thank you for your understanding and look forward to your favorable consideration on the matter at hand. The remainder of the Bill is signed into law and assigned number S.L. No. 11-75. Forwarded is a copy of the bill for your purposes.

A BILL FOR AN ACT

To appropriate the amount \$1,500,000.00 from the Foreign Assistance Fund of the Kosrae State Treasury to fund priority projects in the State; and for other purposes.

1 Section 1. Appropriation. The sum of \$1,500,000.00 is hereby appropriated from
2 the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding
3 priority infrastructure projects in the State of Kosrae, and for other purposes.

4 Section 2. Apportionment. The sum appropriated herein shall be apportioned as
5 follows:

4 Section 3. Allottee. All funds appropriated by this act shall be allotted,
5 managed, administered and accounted for in accordance with applicable laws. The
6 allottee of the fund appropriated by this act shall be the Governor of the State of Kosrae.
7 The allottee shall be responsible for ensuring that these funds, or so much thereof as
8 may be necessary, are used solely for the purpose specified in this act and that no
9 obligations are incurred in excess of the sum appropriated. The authority of the allottee
10 to obligate funds appropriated by this act shall lapse on September 30, 2017.


11 Section 4. Effective Date. This act shall become law upon approval by the
12 Governor or upon its becoming law without such approval.
