A BILL FOR AN ACT

To appropriate the sum of \$91,163.00 from the United States Grant Fund of the Kosrae State Treasury to fund the activities, projects and/or operations of the Kosrae Historic Preservation Office for the year ending September 30, 2016.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$91,163.00 is hereby appropriated from the
2 United States Grant Fund of the Kosrae State Treasury for the purpose of funding the
3 activities, projects, and/or operations of the Kosrae Historic Preservation Office for the
4 year ending September 30, 2016.

5 Section 2. Apportionment. The funds appropriated by this act shall be
6 apportioned as follows:

7	a) Operating Funds	\$22,700.00
8	b) Operating Program	\$8,463.00
9	c) Project Funds	\$60,000.00

10 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be
11 allotted, managed, administered and accounted for in accordance with applicable laws.
12 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
13 shall be responsible for ensuring that these funds, or so much thereof as may be
14 necessary, are used for the purpose for which are appropriated and that no obligations are
15 incurred in excess of the sum appropriated. The authority of the allottee to obligate funds
16 appropriated by this act shall lapse on September 30, 2016.

17 Section 3. Effective Date. This act shall become law upon approval by the
18 Governor or upon its becoming law without such approval.
