A BILL FOR AN ACT

To appropriate the sum of \$4,500.00 from the Revenue Fund of the Kosrae State Treasury to contribute to the 2016 Liberation Day celebrations in the four Municipal Governments in the State and Off-island Kosraean Community (Guam); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section. Appropriation. The sum of \$4,500.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to contribute funding to the 2016 Liberation
3 Day celebrations in the four Municipal Governments in the State and Off-island
4 Kosraean Communities.

5 Section 2. Apportionment. The amount appropriated in Section 1 of this act is
6 apportioned as follows:



13 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
14 administered, and accounted for in accordance with applicable laws. The allottee of the
15 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
16 for ensuring that these funds, or so much thereof as may be necessary, are used for the
17 purpose for which are appropriated and that no obligations are incurred in excess of the
18 sum appropriated.

1 Section 4. Effective Date. This act takes effect upon the approval of the
2 Governor or upon its becoming law without such approval.
