

A BILL FOR AN ACT

To further amend State Law No. 11-33, as amended by State Law Nos. 11-49, 11-61 and 11-78, to extend the lapse date of the Agriculture Development program funding and reapportioning of foreign assistance funding for FY2016 defunded programs by amending at Title, Sections 1,2,3,4,5,6 and 8; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to further amend State Law No.
2 11-33 to extend the lapse date for the FY2016 Compact Sector defunded programs and
3 reapportion foreign assistance funding pursuant to Sections 1, 2, 9 and 10 thereof.

4 Section 2. Amendment. Section 1 of State Law No. 11-33 is hereby amended to
5 read as follows:

6 “Section 1. Appropriations. Operation of the Executive. The sum of \$5,830,089,
7 or so much thereof as may be necessary, is appropriated from the Amended Compact
8 Fund; the sum of \$846,507, or so much as may be necessary, is appropriated from the
9 State Revenue Fund; the sum of \$972,540, or so much as may be necessary, is
10 appropriated from the United States Grant Fund; and the sum of \$291,231, or so much as
11 may be necessary, is appropriated from the Foreign Assistance Fund for the operation of
12 the Executive Branch for the fiscal year ending September 30, 2016. Funding for
13 Subsection (18) of Section 2 shall extend for the fiscal year ending September 30, 2017.”

14 Section 3. Section 2 (2) and (18) of State Law No. 11-33, as amended, are hereby
15 further amended to read as follows:

13 Section 4. Section 9 of State Law No. 11-33, as amended, is hereby

14 further amended to read as follows:

15 “Section 9. Appropriation. Operation of Certain Agencies. The sum of \$88,202, or so
 16 much as may be necessary, is appropriated from the Revenue Fund; the sum of
 17 \$491,912, or so much as may be necessary, is appropriated from the Amended Compact
 18 Fund; the sum of \$56,210, or so much as may be necessary, is appropriated from the
 19 United States Grant Fund; and the sum of \$47,241, or so much as may be necessary, is
 20 appropriated from the Foreign Assistance Fund of the Kosrae State Treasury for the
 21 operation of certain agencies for the fiscal year ending September 30, 2016.”

1 Section 5. Section 10(2) of Kosrae State Law No. 11-33 is hereby amended to
2 read as follows:

3 “(2) The Kosrae Island Resource Management Authority

9 Section 6. Effective Date. This act shall become law upon approval by the
