**A BILL FOR AN ACT**

To appropriate the amount of \$828,300.00 from the Amended Compact Fund of the Kosrae State Treasury to fund FY2017 Compact prior-year/unallocated-funded projects.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The amount of \$828,300.00 is hereby appropriated  
2           from the Amended Compact Fund of the Kosrae State Treasury for the purpose of  
3           funding the FY2017 Compact prior-year/unallocated-funded projects.

4           Section 2. Apportionment. The sum appropriated hereinabove shall be  
5           apportioned as follows:

6	a.	School Acquisition	\$285,000
7	b.	USPC Office Space	\$36,300
8	c.	UES Multi-Purpose Facility	\$130,000
9	d.	Health Dispensary	\$200,000
10	e.	Solar Power Project-OAG	\$162,000
11	f.	Tourism Website	\$15,000

12           Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be  
13           allotted, managed, administered and accounted for in accordance with applicable laws.  
14           The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who  
15           shall be responsible for ensuring that these funds, or so much thereof as may be  
16           necessary, are used for the purpose for which are appropriated and that no obligations  
17           are incurred in excess of the sum appropriated. The authority of the allottee to obligate  
18           funds appropriated by this act shall lapse on September 30, 2017.
