### A BILL FOR AN ACT

To appropriate the sum of \$1,720.00 from the Revenue Fund of the Kosrae State Treasury to provide funding for the upcoming events in the Utwe Municipality; and for other purposes.

### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Appropriation. The sum of \$1,720.00 is hereby appropriated from the		
2	Revenue Fund of the Kosrae State Treasury to provide funding for the 2016 Utwe		
3	Regular Election and Utwe Charter-Public Education.		
4	Section 2. Apportionment. The amount appropriated in Section 1 of this act		
5.	is apportioned as follows:		
6	1. 2016 Utwe Regular Election		
7	2. Utwe Charter – Public Education \$720.00		
8	Section 3. Allottee. All funds appropriated by this act shall be allotted, managed		
9	administered, and accounted for in accordance with applicable laws. The allottee of the		
10	funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible		
11	for ensuring that these funds, or so much thereof as may be necessary, are used for the		
12	purpose for which are appropriated and that no obligations are incurred in excess of the		
13	sum appropriated.		
14	Section 4. Effective Date. This act takes effect upon the approval of the		
15	Governor or upon its becoming law without such approval.
