

A BILL FOR AN ACT

To further amend State Law No. 11-81, as amended by State Law No. 11-88, by amending Section 2(18) thereof, to de-appropriate the sum of \$27,546; adjust appropriated sums, less de-appropriation, at Title, and Section 1; make further technical corrections; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. This act is to further amend State Law No. 11-81, as
2 amended by State Law No. 11-88, by amending Section 2(18), thereof, to de-appropriate
3 the sum of \$27,546, apportioned to DREA (Agriculture Development); to adjust
4 appropriate sums at Title, and Section 1; and to further make certain technical correction;
5 and for other purposes.

6 Section 2. Amendment. State Law No. 11-81 is hereby further amended at Title,
7 Section 1, Subsection 18 of Section 2, and Section 8 to read as following:

8 (1) Title:

9 To appropriate the sum of \$7,074,184 from the Amended Compact Fund, the
10 sum of \$1,942,600 from the State Revenue Fund; the sum of \$1,020,755 from the
11 United States Grant Fund; and the sum of \$55,000 from the Foreign Assistance
12 Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2017,
13 for the purpose of funding the operations of all branches of the Kosrae State
14 Government, its agencies, various programs; and for other purposes.

15 (2) Section 1:

16 Section 1. Appropriation. Operations of the Executive. The sum of \$6,058,062,
17 or so much thereof as may be necessary, is appropriated from the Amended
18 Compact Fund; the sum of \$1,130,206, or so much thereof as may be necessary,

1 is appropriated from the State Revenue Fund; the sum of \$978,931, or so much
 2 thereof as may be necessary, is appropriated from the United States Grant Fund;
 3 and the sum of \$30,000 or so much thereof as may be necessary, is appropriated
 4 from the Foreign Assistance Fund for the operation of the Executive Branch for
 5 the operation for the fiscal year ending September 30, 2017.


