**A BILL FOR AN ACT**

To further amend State Law No. 11-72 to appropriate the \$725,000 Kosrae Community Health Center Program Grant (CHC) for the performance period ending May 31, 2017.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this Act is to amend State Law No. 11-72 to  
2           fully appropriate the Kosrae CHC program funding from \$685,000 to \$725,000 for the  
3           performance period ending May 31, 2017.

4           Section 2. Amendment. Kosrae State Law No. 11-72 is hereby further amended  
5           at Title, Section 1, and Section 2 to read as follows, respectfully:

6                     (1)     “To appropriate the sum of \$725,000 from the United States  
7                     Grant Fund of the Kosrae State Treasury to fund the operations and  
8                     activities of the Kosrae Community Health Center.”

9                     (2)     “Section 1. Appropriation. The sum of \$725,000 is hereby  
10                    appropriated from the United States Grant fund of the Kosrae State  
11                    Treasury for the purpose of funding the operations and activities of the  
12                    Kosrae Community Health Center.”

13           Section 3. Effective Date. This act shall become law upon approval by the  
14           Governor or upon its becoming law without such approval.


