

A BILL FOR AN ACT

To appropriate the sum of \$1,500.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding assistance for the 2017 July 20th Memorial Day Festivities to be held in the Municipality of Utwe; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$1,500.00 is hereby appropriated from
2 the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding
3 assistance for the 2017 July 20th Memorial Day Festivities to be held in the
4 Municipality of Utwe.

5 Section 2. Allottee. All funds appropriated by this act shall be allotted,
6 managed, administered and accounted for in accordance with applicable laws. The
7 allottee shall be responsible for ensuring that these funds, or so much thereof as may be
8 necessary, are used solely for the purpose specified in this act and that no obligations
9 are incurred in excess of the sum appropriated.

10 Section 3. Effective Date. This Act takes effect upon the approval of the
11 Governor or upon it becoming law without such approval.


