

**A BILL FOR AN ACT**

To appropriate the sum of \$2,808.65 from the Local Revenue Fund of the Kosrae State Treasury to fund the special election for Lelu Town Government; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to appropriate the amount of  
2           \$2,808.65 from the Local Revenue Funds of the Kosrae State Treasury to fund the special  
3           election for Lelu Town Government. The special election became due after the untimely  
4           passing of the late and former Mayor Ben Jesse.

5           Section 1. Appropriation. The sum of \$2,808.65 is hereby appropriated from the  
6           Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the Lelu  
7           Town Government special election.

8           Section 2. Apportionment. The amount requested shall be apportioned as  
9           follows:

10           1. Meeting and Allowance	\$2,390.00
11           2. Materials & Supplies w/ others	\$418.65

12           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
13           administered and accounted for in accordance with applicable laws. The allottee of the  
14           said funds appropriated shall be the Governor of the State of Kosrae, who shall be  
15           responsible for ensuring that these funds, or so much thereof as may be necessary, are  
16           used for the purpose for which are appropriated and that no obligations are incurred in  
17           excess of the sum appropriated.

18           Section 4. Effective Date. This act takes effect upon the approval of the


