A BILL FOR AN ACT

To appropriate the sum of \$6,007.00 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of providing additional funding for the Kosrae Forest Legacy Project in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$6,007.00 is hereby appropriated from the
2 Foreign Assistance Fund of the Kosrae State Treasury for the purpose of providing
3 additional funding for the Kosrae Forest Legacy Project in the State of Kosrae.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in accordance with applicable laws.
6 The allottee of the funds appropriated shall be the Chairman of the Board, who shall be
7 responsible for ensuring that these funds, or so much thereof as may be necessary, are
8 used for the purpose for which are appropriated and that no obligations are incurred in
9 excess of the sum appropriated. The authority of the allottee to obligate funds
10 appropriated by this act shall lapse on July 15, 2017.

11 Section 3. Effective Date. This act shall become law upon approval by the
12 Governor or upon it's become law without such approval.
