

A BILL FOR AN ACT

To amend State Law No. 11-87, at the Title, Section 1, Section 2(b), and 3, to change the name, amount and performance period for the USPC Office Space project; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to amend the amount and the lapse  
2           date previously identified for the USPC Office space.

3           Section 2. Amendment. State Law No. 11-87 is hereby amended at the Title,  
4           Section 1, Section 2, and Section 3 to read as follows, respectively:

5                       To appropriate the amount of \$828,000 from the Amended Compact  
6                       Fund of the Kosrae State Treasury to fund FY2017 Compact prior-year/  
7                       unallocated-funded projects.

8                       Section 1. Appropriation. The amount of \$828,000 is hereby  
9                       appropriated from the Amended Compact Fund of the Kosrae State  
10                      Treasury for the purpose of funding the FY2017 Compact prior-year/  
11                      unallocated-funded projects.

12	a.	School Bus Acquisition	\$285,000
13	b.	USPC Office Renovation	\$36,000
14	c.	UES Multi-Purpose Facility	\$130,000
15	d.	Health Dispensary	\$200,000
16	e.	Solar Power Project – OAG	\$162,000
17	f.	Tourism Website	\$15,000

18           Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be  
19           allotted, managed, administered and accounted for in accordance with applicable laws.

1 The allottee of the funds appropriated shall be the Governor of the State of Kosrae,  
2 who shall be responsible for ensuring that these funds, or so much thereof as may  
3 necessary, are used for the purpose for which are appropriated and that no  
4 obligations are incurred in excess of the sum appropriated. The authority of the  
5 allottee to obligate funds appropriated by this act shall lapse on September 30, 2017,  
6 except for Section 2(b) which shall be lapse on September 30, 2018.

7 Section 4. Effective Date. This act shall become law upon approval by the  
8 Governor or upon its becoming law without such approval.
