



A BILL FOR AN ACT

To amend State Law No. 11-118, at the Title section and Sections 11 and 12, to make changes to the Project Management Office (PMO) budget for fiscal year 2018 as awarded by the JEMCO; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to amend State Law No. 11-118, to
2 correct the fiscal year 2018 budget for the PMO, as reflect in the grant award approved
3 by JEMCO.

4 Section 2. Amendment. State Law No. 11-118 is hereby amended at the title and
5 sections 11 and 12 to read as follows:

6 “To appropriate the sum of \$10,488,209 from the Amended Compact Fund; the
7 sum of \$1,988,557 from the State Revenue Fund; the sum of \$970,773 from the
8 United States Grant Fund; and the sum of \$55,000 from the Foreign Assistance
9 Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2018,
10 for the purpose of funding the operations of all branches of the Kosrae State
11 Government, its agencies, and various programs; and for other purposes.”

12 Section 3. Appropriation. The sum of \$3,147,291, or so much thereof as may
13 be necessary, is appropriated from the Amended Compact Fund for the purpose of
14 funding certain Governmental programs, grants, and contributions for the fiscal year
15 ending September 30, 2018.

16 Section 12. Apportionment. The sum appropriated by Section 11 of this act is
17 apportioned as follows:
