A BILL FOR AN ACT

To appropriate the amount of \$75,000 from the Foreign Assistance Fund of the Kosrae State Treasury to provide funding for the Kosrae State Court renovation project; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The amount of \$75,000 is hereby appropriated from  
2           the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the  
3           Kosrae State Court projects.

4           Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be  
5           allotted, managed, administered and accounted for in accordance with applicable laws.  
6           The allottee of the funds appropriated shall be the Chief Justice of the Kosrae State Court,  
7           who shall be responsible for ensuring that these funds, or so much thereof as may be  
8           necessary, are used for the purpose for which are appropriated and that no obligations are  
9           incurred in excess of the sum appropriated.

10          Section 3. Effective Date. This act shall become law upon approval by the  
11          Governor or upon its becoming law without such approval.
