



**A BILL FOR AN ACT**

To amend Section 13.630, Chapter 6 of the Kosrae State Code, by including Section 7.1705 thereto, and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Findings and Purpose. Since the passage of State Law No. 10-149, the  
2           legal characteristics and capacity of the Price Control Commission as an agency of the  
3           Kosrae State Government rendering such services as Government Instrumentality has its  
4           purpose. As a government instrumentality, the Commission is vested with certain powers  
5           and responsibility limited by law. By virtue of Commission's creation under Title 7  
6           Chapter 17, the Commission is vested with powers and duties, which may not be  
7           objectively carried out due to the absence of penalty provision under such Title and  
8           Section by which it is created. The absence of the penalty provision under Title 7,  
9           Chapter 17 although problematic, can still be remedied if Title 13, Section 13.630  
10          is amended to include Section 7.1705 or Price Control Commission.

11          Section 2. Amendments. Section 13.630 of Title 13 of the Kosrae State Code is  
12          hereby amended to read as follows:

13          "Section 13.630. Interfering with authorized officers or observers. Interfering with  
14          authorized officers or observers is an act in violation of Section 19.341 and Section  
15          7.1705 or non-compliance to any government agencies mandated to perform their  
16          respective duties."

17          Section 3. Effective Date. This act shall take effect upon its approval by the  
18          Governor or upon its becoming law without such approval.
