A BILL FOR AN ACT

To appropriate the sum of \$2,000 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding assistance for the Charter Day of the Lelu Town Government and other Municipal events to be recognized and celebrated in the Lelu Municipality in January of 2018; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$2,000 is hereby appropriated from the  
2           Revenue Fund of the Kosrae State Treasury for the purpose of providing funding  
3           assistance for the Lelu Town Government Charter Day and other Municipal events  
4           to be recognized and celebrated in the Lelu Municipality in January of 2018.

5           Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,  
6           administered, and accounted for in accordance with applicable laws. The allottee of the  
7           funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible  
8           for ensuring that these funds, or so much thereof as may be necessary, are used for the  
9           purpose for which are appropriated and that no obligations are incurred in excess of the  
10          sum appropriated.

11          Section 3. Effective Date. This act takes effect upon the approval of the  
12          Governor or upon its becoming law without such approval.


