



A BILL FOR AN ACT

To appropriate the sum of \$116,000.00 from the Amended Compact Fund of the Kosrae State Treasury to fund the Kosrae State FY18 US Army Corps of Engineers (USACE) Program Management Support; and for other purposes.

BE IN ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$116,000.00 is hereby appropriated for the
2 Amended Compact Fund of the Kosrae State Treasury for the purpose of funding the
3 Kosrae State FY2018 USACE Program Management Support.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in accordance with applicable laws.
6 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
7 shall be responsible for ensuring that these funds, or so much thereof as may be necessary
8 are used for the purpose for which are appropriated and that no obligations are incurred
9 in excess of the sum appropriated. The authority of the allottee to obligate funds
10 appropriated by this act shall lapse on September 30, 2019.

11 Section 3. Effective Date. This act shall become law upon approval by the
12 Governor or upon its becoming law without such approval.


