



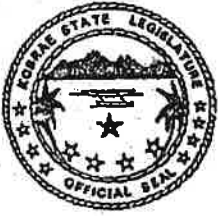

**A BILL FOR AN ACT**

To appropriate the amount of \$18,000.00 from the United States Grant Fund of the Kosrae State Treasury to fund Kosrae Island Resource Management Authority (KIRMA) Forest Legacy Administration.

BE IT ENACTED BY TE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The amount of \$18,000.00 is hereby appropriated from  
2           the United States Grant Fund of the Kosrae State Treasury for the purpose of funding the  
3           KIRMA Forest Legacy Administration.

4           Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be  
5           allotted, managed, administered and accounted for in accordance with applicable laws.  
6           The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who  
7           shall be responsible for ensuring that these funds, or so much thereof as may be  
8           necessary, are used for the purpose for which are appropriated and that no obligations are  
9           incurred in excess of the sum appropriated. The authority of the allottee to obligate funds  
10          appropriated by this act shall lapse on June 30, 2018.

11          Section 3. Effective Date. This act shall become law upon approval by the  
12          Governor or upon its becoming law without such approval.




