A BILL FOR AN ACT

To further amend Title 13, Section 13.703, by inserting a new subsection 13.703(26) to require all front seat passengers and operator of a motor vehicle being operated on a street or main road to wear a properly adjusted and fastened safety belt; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to codify the requirement for front
2 seat passengers and operator of a motor vehicle being operated on a street or the main
3 road to wear a properly adjusted and fastened safety belt.

4 Section 2. Amendment. Title 13, Section 13.703 of the Kosrae State Code is
5 hereby amended to include a new subsection 13.703(26) to read as follows:

6 “(26) Being a front seat passenger or operator of a motor vehicle and not
7 wearing a properly adjusted and fastened safety belt.”

8 Section 3. Effective Date. This act takes effect upon the approval of the
9 Governor or upon its becoming law without such approval.
