

A BILL FOR AN ACT

To further amend State Law No. 11-72, as amended by State Law Nos. 11-94, 11-105, and 11-130 to supplement the operations and activities of the Kosrae Community Health Center Program Grant (CHC) for the performance period ending May 31, 2018.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to further amend State Law No.
2 11-72 as amended by State Law Nos. 11-94 and 11-130 to supplement the Kosrae CHC
3 program for the performance period ending May 31, 2018.

4 Section 2. Amendment. Kosrae State Law No. 11-72, as amended by State
5 Law Nos. 11-94, 11-105, and 11-103 is hereby amended at the Title section, Section 1,
6 and 2 to read as follows, respectively:

7 “To appropriate the sum of \$912,017 from the United States Grants Fund of the
8 Kosrae State Treasury to fund the operations and activities of the Kosrae
9 Community Health Center.”

10 “Section 1. Appropriation. The sum of \$912,017 is hereby appropriated from the
11 United States Grants Fund of the Kosrae State Treasury for the purpose of
12 funding the operations and activities of the Kosrae Community Health Center.”

13 “Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
14 allotted, managed, administered and accounted for in accordance with applicable
15 laws. The allottee of the funds appropriated shall be the Governor of the State
16 of Kosrae, who shall be responsible for ensuring that these funds, or so much
17 thereof as may be necessary, are used for the purpose for which are appropriated.
18 The authority of the allottee to obligate funds appropriated by this act shall lapse
