

A BILL FOR AN ACT

To amend State Law No. 11-133 at the Title and Section 1, to correct the amount appropriated for the Kosrae State Fair; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to amend State Law No. 11-133 to
2 correct the amount appropriated for the Kosrae State Trade Fair; and for other purposes.

3 Section 2. Amendment 1. State Law No. 11-133 is hereby amended at the Title
4 to read as follows:

5 “To appropriate the amount of \$9,380 from the Local Revenue Fund of the
6 Kosrae State Treasury to provide funding for the 2017 Kosrae State Trade Fair; and
7 for other purposes.”

8 Section 3. Amendment 2. State Law No. 11-133 is hereby amended at Section
9 is to read as follows:

10 “Section 1. Appropriation. The amount of \$9,380 is hereby appropriated from
11 the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the
12 2017 Kosrae State Fair.”

13 Section 3. Effective Date. This act takes effect upon the approval of the
14 Governor or upon its becoming law without such approval.


