

A BILL FOR AN ACT

To further amend Kosrae State Code, Title 10, Chapter 2 at Section 10.205(n) to require 5 percent of fees and fines collected from violations on use of tobacco in the State of Kosrae be given to the municipality where such violation takes place; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to provide that 5 percent of monies
2 collected from fees and fines be given with the municipality where such violation occurs.

3 Section 2. Amendment. Title 10, Section 10.205(n) of the Kosrae State Code is
4 hereby amended to read as follows:

5 “Section 10.205. The Revenue Fund.

6 (1) The Revenue Fund contains all monies received by the
7 Government pursuant to a law imposing tax, duty or tariff, and all
8 other revenues and reimbursements from a fine, fee, license,
9 interest, rent, or Government services, and other Government
10 collection or collections by a government for the Government’s
11 benefit except as otherwise required by law. A person who
12 receives monies pursuant to this section transmits the monies
13 within seven days of receipts to the Division of Finance and
14 Budget for deposit in the Revenue Fund except that:

15 (n) The Division of Finance and Budget retains in a Tobacco
16 Coalition Fund all monies collected from payments received
17 for fees and fines from tobacco related penalties. Monies
18 in the Tobacco Coalition Funds are available for the purpose

1 of funding operations of the Tobacco Coalition Taskforce, and also provided
2 that, 5 percent of payments received from fees and fines collected be given
3 to the municipality where such violation occur.”

4 Section 3. Effective Date. This act takes effect upon the approval of the
5 Governor or upon its becoming law without such approval.
