To appropriate the sum of \$2,000 from the Revenue Fund of the Kosrae State Treasury to provide funding for the July 20<sup>th</sup> Memorial Day Liberation to be held in the Municipality of Utwe; and for other purposes.

## BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

| 1  | Section 1. Appropriation. The sum of \$2,000 is hereby appropriated from the               |

| 2  | Revenue Fund of the Kosrae State Treasury to provide funding for the July 20 <sup>th</sup> |
| 3  | Memorial Day Liberation to be held in the Municipality of Utwe.                            |
| 4  | Section 2. All funds appropriated by this act shall be allotted, managed                   |
| 5  | administered, and accounted for in accordance with applicable laws. The allottee of the    |
| 6  | funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible  |
| 7  | for ensuring that these funds, or so much thereof as may be necessary, are used for the    |
| 8  | purpose for which are appropriated and that no obligations are incurred in excess of the   |
| 9  | sum appropriated.  |
| 10 | Section 3. Effective Date. This act takes effect upon the approval of the                  |
| 11 | Governor or upon its becoming law without such approval.                                   |
