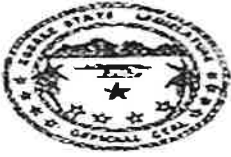

A BILL FOR AN ACT

To appropriate the sum of \$15,000 from the Revenue Fund of the Kosrae State Treasury to provide funding for the 2108 Kosrae State General Election; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$15,000 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to provide funding for the Kosrae State
3 General Election in November 2018.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered, and accounted for in accordance with applicable laws. The allottee of the
6 funds appropriated shall be the Governor of the State of Kosrae, who shall be
7 responsible for ensuring that these funds, or so much thereof as may be necessary, are
8 used for the sum appropriated.

9 Section 3. Effective Date. This act takes effect upon the approval of the
10 Governor or upon its becoming law without such approval.
