

A BILL FOR AN ACT

To amend State Law No. 11-164 at Section 5 and 6(a) to modify the budget for personnel under the operation of the State Court and to further correct the Title section, Section 5 and 6(a) of the State Law Nos. 11-118, to be consistent with this supplemental amendment; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to modify the budget for personnel  
2           under the operation of the State Court at Section 5 and 6(a) and to provide technical  
3           correction to the Title section, section 5 and 6(a) of State Law No. 11-118.

4           Section 2. Amendment. State Law No. 11-118, at Title section, Section 5 and  
5           6(a), is hereby amended to read as follows:

6           “To appropriate the sum of \$10,447,942 from the Amended Compact Fund, the  
7           sum of \$1,958,506 from the Revenue Fund, the sum of \$970,773 from the United States  
8           States Grant Fund; and the sum of \$55,000 from the Foreign Assistance Fund of the  
9           Kosrae State Treasury for the fiscal year ending September 30, 2018, for the purpose of  
10          funding the operations of all branches of the Kosrae State Government, its agencies, and  
11          various programs, for other purposes.

12          Section 5. Appropriation. Operations of the State Court. The sum of \$324,291 or so  
13          much thereof and may be necessary, is appropriated from the Revenue Fund; the sum of  
14          \$25,000, or so much thereof as may be necessary, is appropriated from the Foreign  
15          Assistance Fund of the Kosrae State Treasury for the purpose of operation of the State  
16          Court for the fiscal year ending September 30, 2018.

17          Section 6. Apportionment. Operation of the State Court. The sums appropriated by
