



A BILL FOR AN ACT

To appropriate the sum of \$14,000 from the Revenue Fund of the Kosrae State Treasury to provide funding for the 2018 Liberation Day celebration in the four Municipalities in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$14,000 is hereby appropriated from the
2 Local Revenue Fund of the Kosrae State Treasury to provide funding for the 2018
3 Liberation Day celebrations in the four Municipalities in the State of Kosrae.

4 Section 2. Apportionment. The amount appropriated in Section 1 of this act is
5 apportioned as follows:

6	1.	Lelu	\$4,000
7	2.	Malem	\$3,000
8	3.	Utwe	\$3,000
9	4.	Tafunsak	\$4,000

10 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be
11 allotted, managed, administered, and accounted for in accordance with applicable laws.
12 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
13 shall be responsible for ensuring that these funds, or so much thereof as may be
14 necessary, are used for the purpose for which are appropriated and that no obligations are
15 incurred in excess of the sum appropriated. The authority of the allottee to obligate funds
16 appropriated by this act shall lapse on September 30, 2018.


17 Section 4. Effective Date. This act takes effect upon the approval by the
18 Governor or upon its becoming law without such approval.
