

A BILL FOR AN ACT

To amend S.L. No. 11-176, to provide supplemental funding for Kosrae State General Election held on November 6<sup>th</sup>, 2018; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. To amend S.L. No. 11-176 at the Title and Section 1 to  
2           provide supplementary funding for the Kosrae State General Election held on  
3           November 6<sup>th</sup>, 2018; and for other purposes.

4           Section 2. Amendments. The title and Section 1 shall be amended to read as  
5           follows:

6           “To appropriate the sum of \$16,527 from the Revenue Fund of the Kosrae  
7           State Treasury to provide funding for the General Election to be held in the State of  
8           Kosrae on November 06<sup>th</sup>, 2018; and for other purposes.

9           Section 1. Appropriation. The sum of \$16,527 is hereby appropriated from the  
10          Revenue Fund of the Kosrae State Treasury to provide funding for the General  
11          Election to be held in the State of Kosrae on November 6<sup>th</sup>, 2018.”

12          Section 3. Effective Date. This act takes effect upon the approval of the  
13          Governor or upon its becoming law without such approval.
