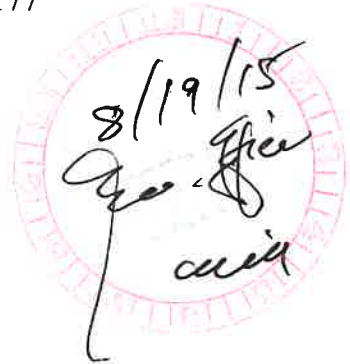



A BILL FOR AN ACT

To amend Section 2 of Kosrae State Law No. 11-11 to change the amounts allocated for the projects titled “Tropical Water Facility” and “TBD Projects” numbered at projects 2 and 9, respectively; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE:

1 Section 1. Purpose. The purpose of this act is to amend Section 2 of Kosrae State Law
2 No. 11-11, to change the amounts allocated for Tropical Water Facility and TBD Projects.

3 Section 2. Amendment. Section 2 of State Law No. 11-11 is hereby amended to read as
4 follows:

5 “Section 2. Apportionment. The sum appropriated herein shall be apportioned as
6 follows:

- 7 1. Semo FacilitSemo Facility/KIDCO Facility\$150,000.00
8 2. Tropical Water Facility\$150,000.00
9 3. Road Pavement\$300,000.00
10 4. Road Resealing (Maintenance):
11 a. Primary Road from Tafunsak to Utwe\$200,000.00
12 b. Walung School Walkway\$10,000.00
13 5. Village Farm Infrastructure:
14 a. Lelu Municipality\$50,000.00
15 b. Tafunsak Municipality\$50,000.00
16 c. Malem Municipality\$50,000.00
17 d. Utwe Municipality\$50,000.00

- 6. Kosrae State Government Building Maintenance:
 - a. Kosrae State Legislature Building\$120,000.00
 - b. Museum/KIRMA Building\$100,000.00
 - c. Health Village Outpost.....\$50,000.00
- 7. Port Facilities Improvement\$100,000.00
- 8. Innem Bridge\$25,000.00
- 9. TBD Projects\$95,000.00

Section 3. Effective Date. This act shall become law upon approval by the Governor or upon its becoming law without such approval.
