

A BILL FOR AN ACT

To appropriate the sum of \$5,000.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding assistance for the 2015 September 8<sup>th</sup> Liberations; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE:

1           Section 1. Appropriation. The sum of \$5,000.00 is hereby appropriated from the  
2 Revenue Fund of the Kosrae State Treasury for the purpose of providing funding assistance for  
3 the 2015 September 8<sup>th</sup> Liberations to be held within all 4 Municipalities of the State. The sum  
4 of \$5,000.00 shall be apportioned as follows:

5           Tafunsak Municipality	\$1,000.00
6           Lelu Municipality	\$2,000.00
7           Malem Municipality	\$1,000.00
8           Utwe Municipality	\$1,000.00

9           Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,  
10 administered and accounted for in accordance with applicable laws. The allottee of the funds  
11 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring  
12 that these funds, or so much thereof as may be necessary, are used for the purpose for which are  
13 appropriated and that no obligations are incurred in excess of the sum appropriated.

14           Section 3. Effective Date. This act shall become law upon approval by the Governor or  
15 upon its becoming law without such approval.
