A BILL FOR AN ACT

To repeal Chapter 1 entitled “Kosrae State Revenue Administration Act of 2011” and Chapter 2 entitled “Value Added Tax Act of 2012” of Title 9 of the Kosrae State Code due to the repealed of FSM Unified Revenue Authority by FSM Congress; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE:

1           Section 1. Chapter 1 of Title 9 of the Kosrae State Code entitled “Kosrae State Revenue  
2 Administration Act of 2011” is hereby repealed in its entirety.

3           Section 2. Chapter 2 of Title 9 of the Kosrae State Code entitled “Value Added Tax Act  
4 of 2012” is hereby repealed in its entirety.

5           Section 3. Effective Date. This act shall become law upon approval by the Governor or  
6 upon its becoming law without such approval.
