A BILL FOR AN ACT

To appropriate the amount of \$3,160.00 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the activities of the 2015 International Day for Disaster Reduction.


BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The amount of \$3,160.00 is hereby appropriated from
2 the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the
3 2015 International Day for Disaster Reduction.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in accordance with applicable laws.
6 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
7 shall be responsible for ensuring that these funds, or so much thereof as may be
8 necessary, are used for the purpose for which are appropriated and that no obligations
9 are incurred in excess of the sum appropriated. The authority of the allottee to obligate
10 funds appropriated by this act shall lapse on October 30, 2015.

11 Section 3. Effective Date. This act shall become law upon approval by the
12 Governor or upon its becoming law without such approval.
