

A BILL FOR AN ACT

To further amend Title 7 of the Kosrae State Code, by amending Section 7.1704 (4) thereof, as amended by State Law No. 10-149, to allow members of the Price Control Commission to be compensated at rate set by law when actually attending meeting of the Commission.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to require that members of the
2 Price Control Commission be compensated when attending meeting of the Commission.

3 Section 2. Amendment. Section 7.1704 (4) of Title 7 of the Kosrae State Code is
4 hereby amended to read as follows:

5 “Section 7.1704. Price Control Commission.

6 (1) There is hereby established a Price Control Commission in Kosrae
7 to be composed of five members appointed by the Governor with the
8 advise and consent of the Legislature. The members appointed shall
9 not include more than one person having a controlling ownership
10 or a managerial interest in one or more businesses in Kosrae. The
11 Director for the Department of Resources and Economic Affairs
12 shall be an ex-officio member of the Commission, without the right
13 vote.

14 (2) The term of office of the appointed members of the Commission shall
15 be two years. Appointments to fill vacancies shall be for the remainder
16 of the unexpired term.


17 (3) At the first meeting and annually thereafter the Commission shall elect
18 a Chairman from among its appointed members. Meetings shall be held

1 at least once a month and may be called by the Chairman, three of the
2 appointed members, or the Governor. A quorum of the Commission
3 shall be four appointed members, and the assent of three members
4 present and voting shall be required for all decisions requiring a vote.
5 With prior approval from the Governor, the Commission shall adopt
6 regulation and by-laws for its own governance.

7 (4) Members of the Commission shall be compensated at rates established
8 by law when actually attending meetings of the Commission. The
9 Department of Resources and Economic Affairs shall offer technical
10 assistance to the Commission and provide records within its possession
11 as requested by the Commission. The Attorney General shall serve as
12 Counsel for the Commission. The Department of Resources and
13 Economic Affairs shall serve as Secretariat for the Commission.”

14 Section 2. Effective Date. This act takes effect upon the approval of the
15 Governor or upon its becoming law without such approval.
