

A BILL FOR AN ACT

To further amend Section 2 of Kosrae State Law No. 11-11, as amended by State Law No. 11-29, to eliminate the projects titled “TBD” numbered at project 9 and to further allocate funds previously under TBD projects to specific projects; and for other purposes.

1           Section 1. Amendment. Section 2 of Kosrae State Law No. 11-11, as amended by  
2           S.L. No. 11-29, is hereby further amended to read as follows:






