A BILL FOR AN ACT

To appropriate the amount of \$2,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of providing meeting allowance for the Price Control Commission; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$2,000.00 is hereby appropriated from the
2 Local Revenue Fund of the Kosrae State Treasury to fund meeting allowance of the
3 Price Control Commission.

4 Section 2. Apportionment. The amount appropriated is Section 1 of this act is
5 apportioned as follows:

8 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
9 administered and accounted for in accordance with applicable laws. The allottee of the
10 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
11 for ensuring that these funds, or so much thereof as may be necessary, are used for the
12 purpose for which are appropriated and that no obligations are incurred in excess of the
13 sum appropriated.

14 Section 4. Effective Date. This act shall become law upon approval by the
15 Governor or upon its becoming law without such approval.


