A BILL FOR AN ACT

To appropriate the sum of \$1,500.00 from the Local Revenue Fund of the Kosrae State Treasury to provide funding for the Kosrae State High School Basketball Team “Warriors” participation in the annual Varsity Basketball Tournament, in Pohnpei on December 19-31, 2015; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$1,500.00 is hereby appropriated from the  
2           Local Revenue Fund of the Kosrae State Treasury for the purpose of providing funding  
3           for the Kosrae High School Basketball Team “Warriors” participation in the annual  
4           Varsity Basketball Tournament, in Pohnpei, on December 19-31, 2015.

5           Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,  
6           administered and accounted for in accordance with applicable laws. The allottee of the  
7           funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible  
8           for ensuring that these funds, or so much thereof as may be necessary, are used for the  
9           purpose for which are appropriated and that no obligations are incurred in excess of the  
10          sum appropriated. The authority of the allottee to obligate funds appropriated by this act  
11          shall lapse on September 30, 2016.

12          Section 3. Effective Date. This act shall become law upon approval by the  
13          Governor or upon its becoming law without such approval.


