A BILL FOR AN ACT

To appropriate the sum of \$90,473 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the activities of “The Project for Renovation of Baseball Ground in Kosrae State”.

1 Section 1. Appropriation. The amount of \$90,473 hereby appropriated from the
2 Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding *The*
3 *Project for Renovation of Baseball Ground in Kosrae State.*

4 Section 2. Allottee and Lapse Dates. All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in accordance with applicable laws.
6 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
7 shall be responsible for ensuring that these funds, or so much thereof as may be
8 necessary, are used for the purpose for which are appropriated and that no obligations are
9 incurred in excess of the sum appropriated. The authority of the allottee to obligate funds
10 appropriated by this act shall lapse on the 31th day of March, 2016.

11 Section 3. Effective Date. This act shall become law upon approval by the
12 Governor or upon its becoming law without such approval.
