A BILL FOR AN ACT

To appropriate the sum of \$7,497 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the Medical Reserve Corps/Citizen Volunteer Corps (MRC/CVC) project of the 2016 Strategic Prevention Framework – Partnership For Success (SPF-PFS).

1           Section 1. Purpose. This act approves, receives and appropriate the US Federal  
2           Grant for the MRC/CVC project of the 2016 SPF-PFS program.

3           Section 2. Appropriation. The sum of \$7,497 is hereby appropriated from the  
4           Foreign Assistance Fund of the Kosrae State Treasury to fund the MRC/CVC project of  
5           the 2016 SPF-PFS Program.

6           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
7           administered and accounted for in accordance with applicable laws. The allottee of the  
8           funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible  
9           for ensuring that these funds, or so much thereof as may be necessary, are used for the  
10          purpose for which are appropriated and that no obligations are incurred in excess of the  
11          sum appropriated.

12          Section 4. Effective and Lapse Dates. This act shall become law upon approval  
13          by the Governor or upon its becoming law without such approval. The funds appropriated  
14          by this act shall lapse on the 29<sup>th</sup> day of September, 2016.
