A BILL FOR AN ACT

To appropriate the sum of \$96,940 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the procurement of a cesspit truck; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$96,940 is hereby appropriated from the
2 Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the
3 procurement of a cesspit truck.

4 Section 2. Allotment. All funds appropriated by this act shall be allotted,
5 managed, administered and accounted for in accordance with applicable laws. The
6 allottee of the fund appropriated by this act shall be the Governor of the State of Kosrae.
7 The allottee shall be responsible for ensuring that these funds, or so much thereof as may
8 be necessary, are used solely for the purpose specified in this act and that no obligations
9 are incurred in excess of the sum appropriated. The authority of the allottee to obligate
10 funds appropriated by this act shall lapse on September 30, 2016.


11 Section 3. Effective Date. This act shall become effective upon the approval of
12 the Governor or upon its becoming law without such approval.
