A BILL FOR AN ACT

To appropriate the sum of \$650,000.00 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the operations and activities of the Kosrae Community Health Center.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$650,000 is hereby appropriated from the  
2           the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the  
3           operations and activities of the Kosrae Community Health Center.


4           Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be  
5           allotted, managed administered and accounted for in accordance with applicable laws.  
6           The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who  
7           shall be responsible for ensuring that these funds, or so much thereof as may be necessary  
8           are used for the purpose for which are appropriated and that no obligations are incurred in  
9           in excess of the sum appropriated. The authority of the allottee to obligate funds  
10          appropriated by this act shall lapse on May 31, 2017.

11          Section 4. Effective Date. This act shall become law upon approval by the  
12          Governor or upon its becoming law without such approval.


