**A BILL FOR AN ACT**

To appropriate the sum of \$92,000 from the United States Grant Fund of the Kosrae State Treasury to fund the programs of the Consolidated Forestry Grant.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$92,000 is hereby appropriated from the  
2           United States Grant Fund of the Kosrae State Treasury for the purpose of funding the  
3           program of the Consolidated Forestry.

4           Section 2. Apportionment. The funds appropriated by this act shall be  
5           apportioned as follows:

9           Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be  
10          allotted, managed, administered and accounted for in accordance with applicable laws.  
11          The allottee of the funds appropriated shall be the Chairman of the KIRMA Board of  
12          Directors, who shall be responsible for ensuring that these funds, or so much thereof as  
13          may be necessary, are used for the purpose for which are appropriated and that no  
14          obligations are incurred in excess of the sum appropriated. The authority of the allottee to  
15          obligate funds appropriated by this act shall lapse on September 30, 2018.

16          Section 3. Effective Date. This act shall become law upon approved by the  
17          Governor or upon its becoming law without such approval.
