A BILL FOR AN ACT

To amend State Law No. 11-61, amending Section 11 thereof, to provide an additional lapse date for the operation funding for the Project Management Office; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to extend the lapse date for
2 operation funding of the Project Management Office.

3 Section 2. Amendment. Section 11 of State Law No. 11-61 is hereby amended to
4 read as follows:

5 “Section 11. Appropriation. The sum of \$3,579,709, or so much thereof as may
6 be necessary, is appropriated from the Amended Compact Fund for the purpose of
7 funding certain Governmental programs, grants and contributions for the fiscal year
8 ending September 30, 2016. Funding for subsection (4) of this section shall extend for
9 the fiscal year ending September 30, 2017.

10 Section 12. Apportionment. The sums appropriated by Section 11 of this act is
11 apportioned as follows:

17 Section 2. Effective Date. This Act takes effect upon the approval of the
18 Governor or upon its becoming law without such approval.
