

A BILL FOR AN ACT

To amend S.L. No. 11-75, to further identify State priority projects to be funded by the \$1,500,000.00 from the Foreign Assistance Fund of the Kosrae State Treasury; and for other purposes.

1 Section 1. Appropriation. The sum of \$1,500,000.00 is hereby appropriated from the
2 Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding priority
3 infrastructure projects in the State of Kosrae, and for other purposes.

4 Section 2. Apportionment. The sum appropriated herein shall be apportioned as follows:

9 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
10 administered and accounted for in accordance with applicable laws. The allottee of the fund
11 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
12 responsible for ensuring that these funds, or so much thereof as may be necessary, are used
13 solely for the purpose specified in this act and that no obligations are incurred in excess of the
14 sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall
15 lapse on September 30, 2017.


