A BILL FOR AN ACT

To supplement State Law No. 11-81 at Section 2(18) to provide funding of \$27,546 for the first two (2) quarters budget for personnel under the Division of Agriculture of the Department of Resources and Economic Affairs and to further correct the Title section and Section 1 of the State Law 11-81, to be consistent with this supplemental amendment; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to provide funding of \$27,546 for
2 the first two (2) quarters budget for personnel under the Division of Agriculture of the
3 Department of Resources and Economic Affairs and to provide technical correction to the
4 Title section and Section 1 of State Law No. 11-81.

5 Section 2. Amendment. State Law No. 11-81, at Title section, Section 1, and
6 Section 2 (18), is hereby amended to read as follows:

7 “To appropriate the sum of \$7,074,184 from the Amended Compact Fund, the
8 sum of \$1,960,195 from the State Revenue Fund; the sum of \$1,020,755 from the United
9 States Grant Fund; and the sum of \$55,000 from the Foreign Assistance Fund of the
10 Kosrae State Treasury for the fiscal year ending September 30, 2017, for the purpose of
11 funding the operations of all branches of the Kosrae State Government, its agencies, and
12 various programs; and for other purposes.

13 Section 1. Appropriation. Operations of the Executive. The sum of
14 \$6,056,088, or so much thereof as may be necessary, is appointed from the Amended
15 Compact Fund; the sum of \$1,130,206, or so much thereof as may be necessary, is
16 appropriated from the State Revenue Fund; the sum of \$978,931, or so much thereof as
17 may be necessary, is appropriated from the United States Grant Fund; and the sum of

1 \$30,000 or so much thereof as may be necessary, is appropriated form the Foreign
2 Assistance Fund for the operation of the Executive Branch for the fiscal year ending
3 September 30, 2017.

4 Section 2. Apportionment. Operation of the Executive. The sums
5 appropriated by Section 1 of this act are apportioned as follows:


