

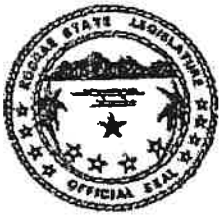

**A BILL FOR AN ACT**

To appropriate the sum of \$2,500.00 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding 2016 Kosrae State Games and assisting the municipalities' preparations for the 2016 Kosrae State Gams; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$2,500.00 is hereby appropriated from the  
2           Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the 2016  
3           Kosrae State Games and assisting the municipalities' preparations for the 2016 Kosrae  
4           State Games.

5           Section 2. Apportionment. The amount appropriated in Section 1 of this act is  
6           apportioned as follows:

- 7           1.     \$500.00 ..... Kosrae State Sports Council  
8           2.     \$500.00 ..... Utwe Municipality  
9           3.     \$500.00 ..... Malem Municipality  
10          4.     \$500.00 ..... Tafunsak Municipality  
11          5.     \$500.00 ..... Lelu Municipality

12          Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
13          administered, and accounted for in accordance with applicable laws. The allottee of the  
14          said funds appropriated shall be the Governor of the State of Kosrae, who shall be  
15          responsible for ensuring that these funds, or so much thereof as may be necessary, are  
16          used for the purposes for which are appropriated and that no obligations are incurred in  
17          excess of the sum appropriated.
