A BILL FOR AN ACT

To appropriate the sum of \$900,000 from the Foreign Assistance Fund of the Kosrae State Treasury and apportioning such sum among the identified priority projects of the State.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$900,000 is hereby appropriated from the Foreign
2 Assistance Fund of the Kosrae State Treasury for the purpose of funding priority infrastructure
3 projects in the State of Kosrae, and for other purposes.

4 Section 2. Apportionment. The sum appropriated herein shall be apportioned as follows:

- 5 1. TBD.....\$894,504
6 2. Inkewosr Seawall.....\$5,496

7 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
8 managed, administered and accounted for in accordance with applicable laws. The allottee of the
9 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
10 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
11 which are appropriated and that no obligations are incurred in excess of the sum appropriated.
12 The authority of the allottee to obligate funds appropriated by this act shall lapse on September
13 30, 2018.

14 Section 4. Effective Date. This act shall become law upon approval by the Governor or
15 upon its becoming law without such approval.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$900,000 is hereby appropriated from the Foreign
2 Assistance Fund of the Kosrae State Treasury for the purpose of funding priority infrastructure
3 projects in the State of Kosrae, and for other purposes.

4 Section 2. Apportionment. The sum appropriated herein shall be apportioned as follows:

- 5 1. TBD.....\$894,504
6 2. Inkewosr Seawall.....\$5,496

7 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
8 managed, administered and accounted for in accordance with applicable laws. The allottee of the
9 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
10 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
11 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

12 The authority of the allottee to obligate funds appropriated by this act shall lapse on September
13 30, 2018.

14 Section 4. Effective Date. This act shall become law upon approval by the Governor or
15 upon its becoming law without such approval.


